#### PRELIMINARY RECITALS

Pursuant to a petition filed on December 11, 2020, under Wis. Admin. Code § HA 3.03(1), to review a decision by the Milwaukee Enrollment Services regarding FoodShare benefits (FS), a hearing was held on January 5, 2021, by telephone.

The issue for determination is whether petitioner's appeal of the denial of replacement FS benefits is moot.

# **FINDINGS OF FACT**

- 1. Petitioner (CARES # ) is a resident of Milwaukee County.
- 2. On December 4, 2020, petitioner submitted an application for \$400 in replacement FS benefits for a loss that occurred on November 27, 2020.

- 3. On December 10, 2020, the agency denied the application for replacement FS benefits.
- 4. On December 11, 220, petitioner appealed.
- 5. Prior to the hearing, the agency acknowledged the application for replacement FS benefits was denied in error. It subsequently approved \$400.00 in replacement benefits.
- 6. On December 14, 2020, \$400.00 in replacement FS benefits were issued to petitioner's FS account.

#### **DISCUSSION**

A matter is moot if the review sought cannot have a practical effect on the existing controversy. See Racine v. J-T Enterp., 64 Wis. 2nd 691, 702; 221 N.W. 2nd 869, 875 (1974). Here, the petitioner was contesting the denial of \$400.00 in replacement FS benefits. That issue is now moot as the agency acknowledged the denial of the replacement benefits was made in error and provided the petitioner the requested replacement benefits. At the hearing, petitioner acknowledged there was no further issue in dispute.

### **CONCLUSIONS OF LAW**

Petitioner's appeal is moot.

#### THEREFORE, it is

#### **ORDERED**

That the appeal is dismissed as moot.

### REQUEST FOR A REHEARING

You may request a rehearing if you think this decision is based on a serious mistake in the facts or the law or if you have found new evidence that would change the decision. Your request must be **received** within 20 days after the date of this decision. Late requests cannot be granted.

Send your request for rehearing in writing to the Division of Hearings and Appeals, 4822 Madison Yards Way, 5<sup>th</sup> Floor North, Madison, WI 53705-5400 **and** to those identified in this decision as "PARTIES IN INTEREST." Your rehearing request must explain what mistake the Administrative Law Judge made and why it is important or you must describe your new evidence and explain why you did not have it at your first hearing. If your request does not explain these things, it will be denied.

The process for requesting a rehearing may be found at Wis. Stat. § 227.49. A copy of the statutes may be found online or at your local library or courthouse.

#### APPEAL TO COURT

You may also appeal this decision to Circuit Court in the county where you live. Appeals must be filed with the Court **and** served either personally or by certified mail on the Secretary of the Department of Health Services, 1 West Wilson Street, Room 651, **and** on those identified in this decision as "PARTIES IN INTEREST" **no more than 30 days after the date of this decision** or 30 days after a denial of a timely rehearing (if you request one).
